The relevance of this topic lies in the necessity of perfection of system of adaptation of adolescents with deviant behavior through social and cultural activities.

The aim of this paper is to review the theoretical basis and practical experience in the adaptation of adolescents with deviant behavior and also to offer socio-cultural forms of adaptation.

To achieve the goal this paper deals with a number of specific tasks:

1. To provide General characteristics of deviant behavior of adolescents as desocialising factor;
