

ABSTRACT OF THE FINAL QUALIFICATION WORK

Subject of the final qualification work:

Structural, compositional and language peculiarities of the text structure of newspaper articles (on the material of the French language).

Author of the final qualification work: Bekova Makka Mukhmadovna

Relevance of the subject of the research: Insufficient study of newspaper and journalistic discourse as a linguistic phenomenon, as well as a very limited number of scientific studies aimed at analyzing French press and teaching students to make a review of journalistic and popular science texts in French.

Aim of the work: Revealing linguistic and extralinguistic features of the newspaper-publicistic style on the basis of French and Russian printed publications.

Tasks:

- 1) to describe the dynamics of genre varieties of newspaper texts;
- 2) to highlight the linguistic peculiarities of an editorial paragraph as an independent newspaper publicistic genre;
- 3) to analyze the newspaper article from the point of view of the total organization of the text structure, as well as the correlation between the headline and the text itself;
- 4) to determine the most characteristic models of division and composition of the main body of the text of an editorial paragraph;
- 5) to note the peculiarities of syntactic structure of an editorial paragraph in terms of local and global text coherence;

6) to highlight stylistic features of the texts of newspaper articles in different publications;

7) to analyze the abstract as a secondary documentary source of newspaper information.

Scientific novelty: Genres and functions of the newspaper and journalistic style have been examined, features of the compositional structure of a newspaper article have been revealed, some ways of making a review of newspaper articles have been analyzed as well as the types of division and formation of text coherence.

The theoretical importance of the research is determined by the refined conception of the newspaper style origin and specifying linguistic and extralinguistic peculiarities of writing a newspaper article. It also provides reasons for the principles of internal organization of the newspaper text and correlation of out-of-text elements with its content.

The practical value of the research is due to the fact that the linguistic tools used in articles from the French press have been identified, and the work provides a clearly structured information about which lexical tools should be used when drafting an article in French, an algorithm for working with the text representing Scientific and journalistic style and a sample of the article and its abstract. Research materials, in particular, applications can be used in practical classes on French in various types of educational institutions, as well as in theoretical courses on lexicology and the style of the French language.

Recommendations: The materials resulted from this study, supplement in particular, may be applied in practical classes while teaching French in various types of educational institutions, as well as in theoretical courses in French lexicology and stylistics.
